The APPLICANT shall indemnify and hold the DOWNTOWN ISSAQUAH ASSOCIATION and the CITY OF ISSAQUAH and its agents, employees, and/or officers, harmless from and shall process and defend at its own expense any and all claims, demands, suites, at law or equity, actions, penalties, loss damages, or costs, of whatsoever kind or nature, brought again the DOWNTOWN ISSAQUAH ASSOCIATION and THE CITY OF ISSAQUAH arising out of or in connection with or incident to the execution of this Agreement and/or the APPLICANT’S performance or failure to perform any aspect of this Agreement; provided, however, that is such claims are caused by or result from the concurrent negligence of the DOWNTOWN ISSAQUAH ASSOCIATION and CITY OF ISSAQUAH, its agents, employees, and/or officers, this indemnity provisions shall be valid and enforceable only to the extent of the negligence of the APPLICANT; and provided further, that nothing herein shall require the APPLICANT to hold harmless or defend the DOWNTOWN ISSAQUAH ASSOCIATION and CITY OF ISSAQUAH, its agents, employees and/or officers for damages or loss caused by the DOWNTOWN ISSAQUAH ASSOCIATION and CITY OF ISSAQUAH’S sole negligence. The APPLICANT expressly agrees that the Indemnification provided herein constitutes the contractor’s waiver of immunity under title 51 R C.W., for the purposes of this Agreement. This waiver has been mutually negotiated by the parties. The provisions of this section shall survive the expiration or termination of this Agreement.

Rules and Regulations

Electricity

Electricity is not available for booths unless special arrangements have been made in advance with the Downtown Issaquah Association and if available.

Hours of Operation

The street closes at 6:00 am the day of the event and the show begins at 8:00 am. The streets will reopen at 5:00 pm sharp and as a result the booths will need to be taken down and off the street by 4:00 pm.

Payment

Payment is due not later than 10 days prior to event (June 8, 2018)

Security

Booth structure and contents, including inventory, are the sole responsibility of the Vendor. The Downtown Issaquah Association and the City of Issaquah do not assume any responsibility of injury to person, loss or damage to nay property of the Vendors, including theft, accidents or acts of God.

Restrictions

- Vendors are not allowed to “rove” with their merchandise at anytime.
- No alcoholic beverage or “loud hawking” are allowed within or in the vicinity of your booth. Music is provided by Fenders on Front Street and prior approval must be given to play any music of substantial volume.

Set Up and Take Down

Vendors are advised of a load in time of 6:00 am to 7:00 am. Please come to the Historic Shell Station at 232 Front Street North to check in and confirm location of booth. Load in vehicles not part of the vendor’s booth and show must be removed from Front Street by 7:30 am. **Late arrivals will not be allowed to drive onto Front Street.**

Please leave the space around your booth clean and free of garbage. This is a volunteer event and all the help you can give us will be greatly appreciated and we would love to see you the following year.
